- 1) The Barbardiya Municipality Office, Jaynagar, Bardiya invites electronic bids from eligible bidders for the **Procurement and Supply of Medicine and Surgical Items** under National Competitive Bidding procedures specified in Public Procurement Act and Regulations.

- 3) Interested Bidders shall have to submit their bid electronically through www.bolpatra.gov.np/egp system only. Hard copy will not be provided or accepted in the office.
- 4) Bids must be submitted on or before 12:00 Noon, 29 October, 2021. Bids received after this deadline will be rejected.
- 5) Bid shall be opened in the presence or in the absence of Bidders' representatives chosen by Bidders to attend at 14:00 *hour* on 29 October 2021 at the office of Barbardiya Municipality, Bardiya.
- 6) Bids must be valid for a period of *90 days counting from the day of* bid opening and must be accompanied by bid security, amounting as specified for each item in the following table, which shall be valid for minimum *30 days* beyond the bid validity period.
- 7) If bidder wishes to submit the Bid Security Amount in the form of cash, the cash should be deposited in Deposit Office Account No. 1122052498251010 (Dharauti Khata) at NIC ASIA Bank, Magragadhi Branch and submit the receipt of the deposited amount of cash along with the bid document and Office Account no: 1122052498251007 (for Bid document cost).
- 8) If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9) Barbardiya Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 10) Any provisions which are not mentioned in this notice will be consistent with PPA 2063, PPR 2064 and prevailing Nepalese Laws.
